Board of Governors Meeting...

Grand Lodge News: We received a check of \$1500 for COVID relief – board approved to apply to building fund (this was part of a 2.7-million-dollar Local Lodge Relief from Grand Lodge).

District Deputy Visit: The pre-visit will be Saturday, September 26 – arrival scheduled for 11 am – will be meeting with Secretary, Treasurer and chairs of specific committees applicable to our Lodge – Judy and Tim have reviewed requests and will present required documents and presentations for his review.

Membership: Tim attended the webinar on yearly membership billing that is totally automated – Lodge could save 42-50% on processing – membership renewals could be paid online or mailed in with a check. Eliminates postcard mailing - will consider for next year – membership cards will still be mailed directly, and all funds directly deposited into our account NOT a national account.

Budget & Finance:

- Board agreed to a \$100 donation to YMCA of Ithaca & Tompkins County.
- Board agreed to a \$50 donation to Tompkins County Deputy Sheriff's Association.

- Board will review budgets before next Lodge meeting September 9th for approval.
- Ads for the Antler one renewal pending two new ads pending.

Mortgage: During the COVID closure we stopped adding additional rental income toward the mortgage – we will resume adding the full rental income to monthly mortgage payment (\$1800/month) – will review and revisit every three months.

Scholarships: Two of three scholarship winners have been sent their \$1,000 – waiting on college enrollment verification for the third.

Calendar Review: Board decided to defer all private parties and large events at this time due to COVID risks involved. Board will also revisit closer to December regarding the Lodge Christmas Party, Children's Christmas Breakfast w/ Santa, New Year's Eve & New Year's Day Parties. Elks Memorial Service is a mandatory service and WILL be held on Sunday, December 6th at 2:00 PM.

Bar & Kitchen: Pat has not been able to cook Friday Food from August 28th through October 2nd due to staffing at his business. Still looking for volunteers to staff the kitchen on Friday Nights. One of the bar cooler compressors has died and replacement ordered, costing around \$500.
